WHEREAS, the Mortgagor is well and truly indebted unto

LIBERTY LIFE INSURANCE COMPANY

, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Twenty-six Hundred - - - - Dollars (\$ 2600.00)**, with interest from date at the rate of **four and one-half** per centum (**4½ %**) per annum until paid, said principal and interest being payable at the office of **Liberty Life Insurance Company** in **Greenville, S.
