NOW, THEREFORE, in consideration of the premises, and of the sum of CRUE DOLLAR to the party of the first part in hand paid by the party of the second part, the receipt of which is hereby fully acknowledged, and, in order to carry out the intention expressed in the premises, the said party of the first part has given, granted, bargained, and sold, and by these presents does give, grant, bargain, sell, alien, assign and convey unto said party of the second part, its successors and assigns, the following described property:
