in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The South Carolina National Bank as Trustee under agreement with Nelson B. Arrington dated March 23, 1945

all that tract or lot of land in

Township, Greenville County, State of South Carolina. in the City of Greenville, on the south side of Byrd Boulevard, and being known and designated as Lots Nos. 146 and 147 as shown on plat of second subdivision of Traxler Park, made by R. E. Dalton, Engineer, in March 1923 and recorded in the R. M. C. Office for Greenville County in Plat Book F, Pages 114 and 115, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a stake on the south side of Byrd Boulevard at joint corner of Lots 147 and 148, said stake being 1264.7 feet in an easterly direction from the southeast corner of the intersection of Byrd Boulevard with Augusta Road and running thence with the south side of Byrd Boulevard, S. 60-28 E. 140 feet to a stake at corner of Lot No. 145; thence along line of said Lot No. 145, S. 29-32 W. 300 feet to a stake in line of Lot No. 117; thence N. 60-28 W. 140 feet to a stake at rear corner of Lot No. 148; thence along line of said Lot No. 148, N. 29-32 E. 300 feet to the beginning corner.
