We, JOHN DAVIDSON VAUGHN and ALMETA CANDLER VAUGHN,
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Twenty Two Hundred and no/100** -----
DOLLARS (\$ 2200.00), with interest thereon from date at the rate of **Five (5%)**
per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, School District 7 H 2 and being known and designated as Lot 181 as shown on plat of East Lynne Addition prepared by Dalton & Neves in May 1933, recorded in Plat Book "H" at page 220 and being more particularly according to said plat as follows:

BEGINNING at an iron pin on the Northwest side of Ridgeway Drive, joint front corner of Lots 181 and 182 and running thence N. 69-42 W. 149 feet to an iron pin; thence S. 17-50 W. 50.05 feet to an iron pin, joint rear corner of Lots 180 and 181; thence with joint line of said lots S. 69-42 E. 152 feet to an iron pin on the Northwest side of Ridgeway Drive; thence with said Drive N. 14-32 E. 50.25 feet to the point of beginning, being the same premises conveyed to the Mortgagors by Roy L. Sisk by deed recorded in Volume 279 at page 337
