"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the Northern side of Fifth Street in Section No. 6 of Judson Mill Village, being known and designated as Lot No. 167 as shown on Plat of Section No. 6 of Judson Mills Village, recorded in Plat Book K at Pages 106 and 107, and having according to said Plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northern side of Fifth Street, joint front corner of Lots Nos. 107 and 108, and running thence with line of Lot No. 108, N. 1-37 W. 136.7 feet to an iron pin in line of Lot No. 25; thence with the line of Lot No. 25, S. 88-23 W. 71 feet to an iron pin, corner of Lot No. 106; thence with line of Lot No. 106, S. 1-37 E. 135.5 feet to an iron pin on the Northern side of Fifth Street; thence with the Northern side of Fifth Street, N. 89-25 E. 71 feet to the beginning corner."
