I, W. T. Watson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Two Thousand and No/100- - - - - DOLLARS (\$ 2,000.00 ), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Hilltop Drive in Bates Township, being shown as Lot No. 13 on Plat of the Property of Ray E. McAlister, recorded in Plat Book S at Page 153, and having according to said Plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southern side of Hilltop Drive at the joint front corner of Lots Nos. 12 and 13, and running thence with the line of Lot No. 12, S. 44-12 W. 200 feet to an iron pin; thence S. 45-48 E. 100 feet to an iron pin at corner of Lot No. 14; thence with the line of said lot, N. 44-12 E. 200 feet to an iron pin on Hilltop Drive; thence with the Southern side of Hilltop Drive, N. 45-48 W. 100 feet to the point of beginning corner."

Said premises being the same conveyed to the mortgagor by Ray E. McAlister by deed to be recorded.
