(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-five Hundred and No/100- - - - - DOLLARS (\$ 2,500.00 ), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lots Nos. 49 and 50 on Plat of the property of H. G. Stevens prepared by W. J. Riddle in April 1941, recorded in Plat Book M at Page 9, and described as follows:

"BEGINNING at an iron pin at the Northwestern intersection of Markley Avenue and Paris View Drive, and running thence with Markley Avenue, N. 49-20 W. 223.4 feet to an iron pin in line of Lot No. 33; thence with the line of said lot, N. 2-30 W. 106.4 feet to an iron pin at joint rear corner of Lots Nos. 48 and 49; thence with the joint line of said lots, N. 87-30 E. 209 feet to an iron pin on the West side of Paris View Drive; thence with said Drive, S. 6-20 E. 155 feet to the point of beginning."

Said premises being the same conveyed to the mortgagors by Octavia DuPree Pridmore, Individually and as Executrix, recorded in Book of Deeds 414 at Page 238.
