TO ALL WHOM THESE PRESENTS MAY CONCERN: We, J. C. Wilson and Nell S. Wilson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Four Hundred and No/100- - - - - DOLLARS (\$ 5400.00), with interest thereon from date at the rate of Five (5%)- per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot No. 87, on revised Map of Park Hill, recorded in the R.M.C. Office for Greenville County in Plat Book J at Pages 208 and 209, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northwest side of Melville Avenue, at the joint front corner of lots Nos. 86 and 87, and running thence with the line of lot 86, N. 54-03 W. 153.4 feet to an iron pin; thence S. 20-09 W. 67.6 feet to an iron pin; thence with the line of lot 88, S. 54-03 E. 155 feet to an iron pin on the Northwest side of Melville Avenue; thence with the Northwest side of Melville Avenue N. 35-57 E. 65 feet to the beginning Corner."
