(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three

Thousand Two Hundred DOLLARS (\$ 3,200.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter, become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick

Springs Township, within the new City limits of Greer, lying on the South side of Wilson Avenue and on the West side of Earle Street, being all of lot No. 5 on a plat of property made for Nancy W. Finley and Ellen W. Crain by H.S. Brockman, Surveyor, dated June 24, 1941, and having the following courses and distances: BEGINNING on a stake at the intersection of said two streets, and runs thence with the West side of Earle Street S. 14.02 E. 70 feet to a stake, corner of lot No. 6; thence S. 80.59 W. 221 feet to a stake, corner with lot No. 4; thence N. 7.29 W. 70 feet to a stake on the South side of Wilson Avenue; thence therewith N. 81.06 E. 213 feet to the beginning corner, and being all of that property conveyed to me by deed from Laurens I. James dated Sept. 7, 1946, recorded in the R.M.C. Office for Greenville County in Deed Book 298, at page 439.
