in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

The Peoples National Bank of Greenville, S. C., its successors and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, School District 7-ID, now within the corporate limits of the City of Greenville, being known and designated as Lot No. 95 of the property of John A. Carson as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book W, at page 143, which plat is a re-subdivision of a portion of a subdivision known as "Dixie Heights" as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book H, at page 46. The above described lot is composed of a portion of Lots Nos. 95 and 96 of the original Dixie Heights subdivision, and has, according to the Carson plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Lowndes avenue at the corner of Lot No. 96-97, which pin is 204 feet northeast of the intersection of Lowndes Hill Road, and running thence along the East side of Lowndes Avenue, N. 45-12 E. 60 feet to an iron pin at the corner of Lot No. 94; thence along the line of Lot No. 94, S. 46-48 E. 150 feet to the original line of Lot No. 99; thence along the original line of Lot No. 99, S. 45-12 W. 60 feet to the line of Lot No. 96-97; thence along the line of Lot No. 96-97, N. 46-48 W. 150 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, its successors ~~Heirs~~ and Assigns, from and against me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.
