To All Whom These Presents May Concern:

I, GARY V. JONES

SEND GREETING:

Whereas, I, the said Gary V. Jones
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to First National Bank of Greenville, S. C.
as Trustee, under F. W. Symmes Trust Agreement, dated May 6, 1947,
in the full and just sum of Twenty-Three Hundred Dollars, (\$2300.00)
to be paid One Hundred Dollars, (\$100.00), on the 18th day of
February, 1951, and a like amount on the 18th day of each and every succeeding
month thereafter until paid in full

with interest thereon from date hereof
at the rate of five per centum per annum, to be computed and paid monthly
until paid in full: all interest not paid when due to bear
interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to

Agreement, dated May 6, 1947,

All that piece, parcel or lot of land in Butler Township, Greenville County,
State of South Carolina, in School District 7-H, on the corner of the Laurens Road
and Dakota Avenue, described according to a plat of the same made by J. C. Hill on
January 20, 1949, and recorded in the R. M. C. Office for Greenville County, South
Carolina, in Plat Book "V" at Page 59 as follows:
BEGINNING at an iron pin at the junction of the Laurens Road and Dakota Avenue
and running thence with the Laurens Road S. 31-30 E. 54 feet to an iron pin; thence
S. 45-53 W. 43 feet to an iron pin; thence N. 57-24 W. 39.1 feet to an iron pin at
