released, and by these presents do grant, bargain, sell and release unto the said C. E. Robinson,
as Trustee under the B. M. McGee Trust Deed, his successors and assigns,
forever:

All those certain pieces, parcels or lot of land in Greenville
County, State of South Carolina, in Greenville Township, now a part of
the City of Greenville, known and designated as Lots Nos. 11 and 12, on
Plat of property of White and Bruce, said plat being recorded in the
R. M. C. Office for Greenville County in Plat Book E, Page 59, being
situate on the South side of Bruce Street, and having the following
metes and bounds, to-wit:

BEGINNING at an iron pin at joint corner of Lots Nos. 1 and 11,
and running thence N. 67 E. 72 feet to an iron pin; thence N. 9 1/2 W.
