"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in School District of, on the South side of Blythewood Drive, being shown as lot No. 100, Plat 2 of Camilla Park Subdivision, property of John B. Marshall Estate, recorded in Plat Book M at Page 85, and having the following metes and bounds, to-wit:
