All that tract or lot of land/in Greenville County, State of South Carolina, in School District 4-H and on the south side of the County Road leading from Woodville to Pelzer, and having the following metes and bounds to wit:

BEGINNING at a point in the center of the said Pelzer Road, (stone on East Bank of Road, and running thence with the Chandler line S. 15-20 E. 32.9 feet to a stone; thence S. 15-20 E. 484 feet to an iron pin; thence S. 87-30 W. with the W.W. Lindley line 352.5 feet to an iron pin; thence N. 15-20 W. 509 feet to an iron pin, 26.4 feet from center of the road; thence 15-20 W. 26.4 feet to the center of said Pelzer Road; thence S. 88-30 E. along the center of the Pelzer-Road 360 feet to the point and place of beginning, containing 3.93 acres, more or less. bounded by lands of J.
