SEND GREETING:

Whereas, I, the said J.E. Bennett

in and by my certain promissory note in writing, of even date with these Presents, am well and truly indebted to Bank of Greer, Greer, S.C.

in the full and just sum of Ninety seven hundred fifty (\$9750.00) Dollars, to be paid as therein stated

with interest thereon from maturity at the rate of 5 per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, in the town of Greer and on Church Street of said Town, and having the following metes and bounds to wit:

BEGINNING at a stake on J.E. Gibson's line, and runs thence S 76 1/2 E. 88 feet 10 inches to a stake; thence N. 32 3/4 E 200 to Church Street; thence N. 76 1/2 W 96 1/3 to a stake in Street, J.E. Gibson's corner; thence S. 25 3/4 W 200 feet to the beginning corner, containing 42/100 of an acre, and being the same conveyed to me by deed from D.M. Frierson on June 30, 1941, recorded in R.M.C.
