"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the village of Highland, in Highland Township, containing Two and one-tenth (2.10) Acres, more or less, and having the following courses and distances, to wit: Beginning at an iron pin in State Highway No. 414, and running thence N. 11.00 W. 276 feet to a stake; thence N. 59.45 W. 273 feet to a stake on the M.A. Hall line; thence with the Hall line, S. 7.15 E. 546 feet to a stake in said highway No. 414; thence with the center of the highway, N. 58.30 E. 258 feet to the beginning corner.
