porated herein by reference, in the principal sum of Seventy-six Hundred and No/100- - - -
- - - - - Dollars (\$7600.00), with interest from date at the rate of
Four per centum (4 %) per annum until paid, said principal and interest being payable
at the office of C. Douglas Wilson & Co.
in Greenville, S. C., or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Forty and 12/100-
- - - - - Dollars (\$40.12), commencing on the first day of
August, 19 51, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina;

All that lot of land with the improvements thereon situate on the
Northwest side of Mayo Drive, near the City of Greenville, in Greenville
County, State of South Carolina, shown as Lot 224, on plat of Paramount
Park, made by Piedmont Engineering Service, July 1949, recorded in the
R. M. C. Office for Greenville County, S. C., in Plat Book "W", at page
57, said lot fronting 102 feet along the Northwest side of Mayo Drive,
running back to a depth of 96.8 feet along the Southwest side, to a depth
of 140.1 feet on the Northeast side and being 90 feet across the rear.

ALSO, that 30 gallon electric water heater in the dwelling on the
above property which the mortgagor herein acknowledges to be a part of
