I, H. E. Hembree

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eight Thousand and No 100- - - - - DOLLARS (\$8000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All ~~the~~ ^{those} certain piece^s, parcel^s/or lot^s of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Linda Avenue, near the City of Greenville, being shown as lots 6 and 10 on plat of Gantt Heights, recorded in Plat Book W at Page 143, and described as follows:

"LOT 6 BEGINNING at a stake on the South side of Linda Avenue, at corner of lot 5, and running thence with the line of said lot, S. 23-00 W. 164.1 feet to a stake; thence S. 69-12 E. 59.95 feet to a stake at corner of lot 7; thence with the line of said lot, N. 23 E. 165.4 feet to a stake on Linda Avenue; thence with the Southern side of said Avenue, N. 70-30 W. 60 feet to the beginning corner.

"LOT 10: BEGINNING at a stake on the Southern side of Linda Avenue, at corner of lot 9, and running thence along line of said lot, S. 23 W. 169.5 feet to a stake; thence S. 69-12 E. 59.95 feet to a stake at corner of lot 11; thence with the line of said lot, N. 23 E. 170.8 feet to a stake on Linda Avenue; thence with the South side of Linda Avenue, N. 70-30 W. 60 feet to the beginning corner."
