(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty-one Hundred Twenty-five and No/100- --- DOLLARS (\$ 6,125.00), with interest thereon from date at the rate of five & one-half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Tract No. 2, as shown on Plat of property of E. R. Haynie recorded in Plat Book S. at Page 163, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the South side of the Woodruff Road, which pin is 200 feet East of an 18-foot road, and is the joint front corner of Tracts 1 and 2, and running thence with the joint line of said tracts, S. 24-45 E. 511.7 feet to an iron pin in line of Tract 13; thence with line of said tract, N. 64-20 E. 200 feet to an iron pin in line of Tract 3; thence with line of said tract, N. 24-45 W. 506.7 feet to an iron pin in the South side of Woodruff Road; thence with said Road, S. 64-15 W. 200 feet to the point of beginning".
