"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Eastern side of Ashmore Bridge Road, in Austin Township, containing .64 of an acre, as shown on plat of property of J. H. Blakely made by W. J. Riddle, October 23, 1951 and described as follows:
