.Wooten and his heirs and assigns:

All of that parcel or tract of land in Chick Springs Township of Greenville County, South Carolina, lying on the North side of the Bright Road, about one-half mile from the City of Greer, known and designated as tract 'No. 5 on a plat of property made for the J.B. Burnett Estate by H.S. Brockman, Surveyor, dated March 3, 1937, and having the following courses and distances:

BEGINNING on a stake in the center of said Bright Road, on line of property formerly owned by N.E.
