We, Thomas Earl Thompson, Jr. and
Betty L. Thompson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and No/100- - - - - DOLLARS (\$ 6,000.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Carolina Avenue, in the City of Greenville, being shown as Lot No. 7 of Block K, Section 5, on Plat of East Highlands Estates made by Dalton & Neves, Engineers, in February 1941, recorded in Plat Book K at Pages 78, 79 and 80, and described as follows:

"BEGINNING at an iron pin on the Northern side of Carolina Avenue, at the joint front corner of Lots Nos. 5 and 7, and running thence with the line of Lot No. 5, N. 17-39 W. 181.4 feet to a pin on the Southern edge of a 5-foot reserved for utilities; thence along the Southern edge of the strip of land reserved for utilities, S. 73-0 W. 47.9 feet to iron pin; thence with the line of Lot No. 9, S. 7-13 E. 170 feet to iron pin on the Northern side of Carolina Avenue; thence with the Northern side of Carolina Avenue, N. 82-47 E. 80 feet to the beginning corner."

Said premises being the same conveyed to the mortgagors by deed recorded in Book of Deeds 445 at Page 221.

The mortgagor, Thomas Earl Thompson, Jr., is the identical person referred to as Grantee in the above mentioned deed as Thomas Earl Thompson.
