WHEREAS: I, Donald J. Zachman

Greenville, S. C. , hereinafter called the Mortgagor, is indebted to

, a corporation
organized and existing under the laws of South Carolina , hereinafter
called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-
porated herein by reference, in the principal sum of Eighty-Five Hundred and No/100- - - -
Dollars (\$ 8500.00), with interest from date at the rate of
Four- - - per centum (4 %) per annum until paid, said principal and interest being payable
at the office of Fidelity Federal Savings & Loan Association
in Greenville, S.C. , or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty-Two & 52/100
Dollars (\$ 52.52), commencing on the first day of
May , 19 52, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of April , 19 72 .

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina; in the City of Greenville, being shown and designated as lot No.
48 on a plat of Northwood Subdivision, recorded in Plat Book J at Pages 102 and 103,
and described as follows:

BEGINNING at an iron pin on the Southern side of Woodbine Road, at the
joint front corner of lots 47 and 48, and running thence with said Road, S. 72-36 W.
60 feet to an iron pin, corner of lot 49; thence with line of said lot, S. 14-40 E.
148.7 feet to an iron pin, corner of lot 26; thence N. 70-50 E. 75 feet to corner
of lot 47; thence with the line of said lot, N. 20-32 W. 146.5 feet to the point
of beginning. Being the same premises conveyed to the mortgagor by Milford Carter
by deed to be recorded herewith.
