To All Whom These Presents May Concern: I, Thelma E. Smith

SEND GREETING:

Whereas, I, the said Thelma E. Smith hereinafter called the mortgagor(s) in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to Shenandoah Life Insurance Company, Inc. hereinafter called the mortgagee(s), in the full and just sum of Ten Thousand

DOLLARS (\$10,000.00), to be paid \$66.00 on the 2nd day of May, 1952 and a like amount on the 2nd day of each and every month thereafter until the entire principal sum is paid in full, said installments to be applied first in payment of interest and then to principal, balance due 20 years from date

, with interest thereon from date at the rate of five (5%) percentum per annum, to be computed and paid

monthly until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land situate, lying and being in the corporate limits of the city of Greenville, Greenville County, state of South Carolina and being known and designated as lot No. 2 on plat of property of J. O. Lewis, plat made in 1924, and having the following metes and bounds, according to a more recent survey by T. C. Adams, to-wit:

Beginning at an iron pin on the western side of Faris Road, joint front corner of lots 1 & 2, and running thence S. 16-50 W. 70 feet to an iron pin, the joint front corner of lots 2 & 3; thence with the joint line of said lots 2 & 3, N. 69-46 W. 210 feet to an iron pin; thence N. -02 E. 70.7 feet to an iron pin the joint rear corner of lots 1 & 2; thence with the joint line of said lots 1 & 2, S. 69-46 E. 195 feet to the beginning corner.
