All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Southwest side of North Brookwood Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 14 on revised plat of Park Hill, made by Dalton & Neves, Engineers, May 1940, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "J", Pages 208 and 209, and having, according to said plat and a recent survey made by R. E. Dalton, Engineer, January 9, 1942, the following metes and bounds, to wit:
