NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, lying on the South side of the Ballenger Road, sometimes known as the Taylor Road, about $2\frac{1}{2}$ miles North from the City of Greer, known and designated as Lot No. 2 on a plat of property made for W. Dennis Smith by H.S. Brockman, Surveyor, dated July 29, 1952, to be hereafter recorded, and having the following courses and distances: BEGINNING on an iron pin in said road, corner with Mamie Ballenger's land, and runs thence with the line of this property S. 22.53 E. 195 feet to a stake, joint rear corner of Lots Nos. 2 and 4; thence with the common line of these lots S. 83.40 W. 199.5 feet to a stake on the East side of a new cut road or street; thence with the eastern edge of said road or street N. 19.45 W. 205 feet to a stake on the South side of the Ballenger road; thence along said Ballenger Road N. 87.20 E. 191 feet to the beginning corner, and being a portion of that property conveyed to me Herman J.
