We. Ansel Alewine, as Trustee, and H. J. Duncan, consenting SEND GREETING:
WHEREAS, I the said Ansel Alewine, as Trustee,
in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Ten Thousand and No/100 (\$ 10,000.00) five (5%) Dollars, with interest at the rate of six/(6%) per centum per annum, to be repaid in instalments of One Hundred and No/100 (\$ 100.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days or failure to complete the thereunder shall be past due and unpaid for a period
