"All that certain piece, parcel or lot of land with all improvements thereon or to be constructed

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Buist Avenue near the City of Greenville, and being known and designated as Lot No. 12 in a subdivision known as Oakhurst, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book I, at page 84, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the south side of Buist Avenue at the joint corner of Lots Nos. 11 and 12, which point is 174 feet east from the southeast corner of the intersection of Rutherford Road and Buist Avenue, and running thence along the line of said Buist Avenue, S. 65-16 E. 55 feet to an iron pin at the joint front corner of Lots Nos. 12 and 13; thence along the joint line of said lots, S. 30-49 W. 149 feet to an iron pin at the joint rear corner of said lots in the line of Lot No. 17; thence along the line of Lot No. 17, N. 65-16 W. 55 feet to an iron pin at the joint rear corner of Lots Nos. 12 and 11; thence along the joint line of said lots, N. 30-49 E. 149 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
