"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the eastern corner of Harrington Avenue and DuPont Drive, being the western portion of Lot 76 as shown on plat of Isaqueena Park made by Pickell and Pickell on June 7, 1947, recorded in Plat Book P at Pages 130-131, and described as follows:
