NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Northwest side of Cammer Avenue, being known and designated as lot 12 as shown on plat of Augusta Road Hills, recorded in rlat Book L at 'ages 56 and 57, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin in the Northwest side of Cammer Avenue, joint front corner of lots 12 and 13, and running thence with joint line of said lots, N. 47-50 W. 193 feet; thence N. 42-07 E. 82.5 feet to an iron pin; thence S. 41-55 E. 212 feet to an iron pin in the Northwest side of Cammer Avenue; thence with said Avenue, S. 58-09 W. 63.7 feet to the point of beginning."
