"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Bates Township on the North side of an old settlement road, containing seven-eights (7/8) of an acre, and being known and designated as Lot No. 3 of the property of O. A. Foster, as shown on plat thereof made by W. A. Hester, Surveyor, on March 8, 1949, and recorded in the R. M. C. office for Greenville County in Plat Book T, at page 115, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of an old settlement road at the corner of Lot No. 2, which point is 4.67 chains west of the intersection of said road with the Geer Highway; thence along the line of said Lot No. 2, N. 11 W. 5.50 chains to an iron pin in line of property now or formerly belonging to Frank Guest Estate; thence along the line of that property, S. 80 3/4 W. 1.52 chains to an iron pin at the corner of other property of O. A. Foster; thence along the line of that property, S. 11 E. 6.00 chains to an iron pin on the north side of an old settlement road; thence along the line of the old settlement road, N. 66 E. 1.52 chains to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to me by Eston O. Foster by his deed dated May 4th, 1953 and recorded in the R. M. C. office for Greenville County in Vol. 479, at page 203."
