"All that certain piece, parcel or lot of land; with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, in the City of Green, lying on the South side of Buncombe Street, known and designated as Lots Nos. 28 and 29 on a plat of the N.M. Carmon property made by H.S. Brockman, Surveyor, dated January 16, 1924, recorded in the R.M.C. Office for Greenville County in Plat Book "F", at page 199, and having the following courses and distances: Beginning at a stake on Buncombe Street, joint corner of lots Nos. 29 and 30, and runs thence S. 13.00 E. 150 feet to a stake; thence S. 76.45 W.190 feet to a stake; thence N. 13.00 W. 150 feet to a stake on the South side of Buncombe Street N. 76.45 E. 100 feet to the beginning corner, and being all of that lot of land conveyed to me by E.R. Taylor and that lot conveyed to me by J.W. Greer, the latter deed to be recorded herewith.
