), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid: Fifty (\$50.00) Dollars on October 1st. 1953, and a like payment of \$50.00 on the 1st. day of each consecutive month thereafter until paid in full. Said payments to be first applied to interest, balance to principal.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Blythewood Drive, in the City of Greenville, being shown as lot No. 34 on plat recorded in Plat Book "Y" at page 111, and having according to said plat the following metes and bounds, to wit:

" BEGINNING at an iron pin on the Eastern side of Blythewood Drive at joint front corner of lots 34 and 35, and running thence with lot 35, S. 78-25 W. 143.9 feet to iron pan; thence with line of lot 38, S. 24-56 E. 56.6 feet to iron pin at rear corner of lot 33; thence with line of lot 33, S. 75-04 W. 137.1 feet to iron pin on Blythewood Drive; thence with the East side of Blythewood Drive, N. 29-21 W. 65.5 feet to point of beginning. Being the same premises conveyed to the mortgagor by the mortgagee by deed to be recorded."
