"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the south side of Edgemont Road, being known and designated as the Northern portion of Lot No. 73 on plat of the property of the G. J. Douglas Estate, recorded in the R. M. C. office for Greenville County in Plat Book F, at page 126, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the south side of Edgemont Road at the corner of Lot No. 74, which point is 287 feet east of Cothran street, and running thence along the line of Lot No. 74, in a southwesterly direction 125 feet to an iron pin; thence S. 63-24 E. 75.1 feet to an iron pin in line of Lot No. 72; thence along the line of that lot, in a Northeasterly direction, 125 feet to an iron pin at the corner of said lot on the south side of Edgemont Road; thence along the line of Edgemont Road, N. 63-24 W. 75.1 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
