All that lot of land with the buildings and improvements thereon, situate on the southeast side of Perrin Street, in the City of Greenville, in Greenville County, S. C., shown as Lot No. 14 on plat of property of A. A. Green, made by Pickell & Pickell, Engineers, November 9, 1945, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "M", at Page 145, said lot fronting 80 feet along the southeast side of Perrin Street and running back to a depth of 189 feet on the northeast side, to a depth of 191 feet on the southwest side and being 79.6 feet across the rear.
