NOW KNOW ALL MEN, That I/We, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Chick Springs Township, lying about one mile North from Chick Springs and the New U. S. Super Highway No. 29, lying on the East side of the St. Mark paved road, being all of Lot No. 2 on a plat of property made for D. H. McKinney by J. Earle Freeman, Surveyor, which plat is on record in the R. M. C. office for Greenville County in Plat Book I, at page 151, having the following courses and distances:

"BEGINNING on an iron pin on the East edge of the St. Mark Road, joint corner of Lots Nos. 2 and 3 on said plat, and runs thence with the common line of these lots, N. 68 E. 300 feet to an iron pin; thence S. 22 E. 50 feet to an iron pin, corner of Lot No. 1; thence with the line of Lot No. 1, S. 68 W. 300 feet to an iron pin on the East side of said road; thence with East edge of said road, N. 22 W. 50 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
