sold and released, and by these presents do grant, bargain, sell and release unto the said

South Carolina National Bank, As Trustee for Greenville News-Piedmont Employees  
Trust, its successors and assigns forever:

All that piece, parcel or lot of land in the City of Greenville on the east side of  
North Main Street and being known and designated as Lot No. 13, Block H and the  
southern one-third of Lot No. 26, Block H of Northgate Subdivision, plat of which is  
recorded in the R. M. C. Office for Greenville County in Plat Book "M", page 13 and  
having the following metes and bounds:

BEGINNING at an iron pin on the east side of North Main Street front corner of  
Lots Nos. 12 and 13; thence with line of said lots in an easterly direction 200 feet  
to an iron pin; thence in a northerly direction with rear line of Lots Nos. 29 and 30  
100 feet to an iron pin; thence in a westerly direction 200 feet to iron pin on North
