MORTGAGE OF REAL ESTATE Greenville COUNTY OF..... To All Whom These Presents May Concern: I, Naomi K. Hayworth, of Greenville County, WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-VILLE, in the full and just sum of Fourteen Thousand and No/100 - - - - - - - - -(\$ 14,000.00) Dollars, with interest at the rate specified in said note, to be repaid in installments of One Hundred, Fighteen and No/100 -, - - - - - - - - - - - - (\$ 118.00)

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage: said note further providing for ten (10%) per centum attorney's who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as

M. C. office for Greenville County in Plat Book H, at pages 178 and 179, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of East North Street at the corner of Lot No. 1, which point is 70.7 feet north from the northwest corner of the intersection of East North Street and Richland Avenue, and running thence along the line of Lot No. 1, N. 77-03 W. 180.8 feet to an iron pin in the line of Lot No. 25; thence along the line of that lot, N. 20-41 E. 70.3 feet to an iron pin at the rear corner of Lot No. 3; thence along the line of that lot, S. 77-03 E. 163.4 feet to an iron pin at the corner of said lot on the west side of East North Street; thence along the line of said East North Street, S. 6-24 W. 70 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
