NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, near Judson Mills Village, and being known and designated as Lots Nos. 1 and 3 of a subdivision of the property of Judson Mills Village known as "Edgement", as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book D, at page 35, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the southwest corner of the intersection of Piedmont Avenue and Easley Bridge Road, and running thence along the west side of Piedmont Avenue, S. 9-30 E. 142 feet to an iron pin at the joint corner of Lots Nos. 3 and 5; thence along the joint line of said lots, S. 80-30 W. 150 feet to an iron pin on the east side of the right-of-way of the Piedmont & Northern Railway; thence along the line of said right-of-way, N. 9-30 W. 112 feet to an iron pin at the southeastern intersection of said P. & N. Railway right-of-way with the Easley Bridge Road; thence along the south side of said Easley Bridge Road, N. 70 E. 151 feet to the beginning corner; less, however, the property heretofore conveyed to the Highway Commission for widening Easley Bridge Road, one of which deeds is recorded in the R. M. C. office for Greenville County in Vol. 448, at page 403.

"The above described lot is the same which was conveyed to Eunice C. Johnson and Fred Johnson by L. C. Hopkins by deed dated March 24, 1944 and recorded in the R. M. C. office for Greenville County in Vol. 262, at page 148, the said Fred Johnson having since conveyed his undivided one-half interest therein to Eunice C. J. Gunter by deed dated November 28, 1951 and recorded in the R. M. C. office for Greenville County in Vol. 446, at page 501.

"This mortgage also covers the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty."
