"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Pecan Drive hear the City of Greenville, being shown as Lot No. 35 on a plat of Pecan Terrace made by Piedmont Engineering Service on August 27, 1953, recorded in Plat Book "GG" Page 9, and described as follows:

"BEGINNING at a stake on the eastern side of Pecan Drive 171.6 feet northwest from Mayflower Avenue at corner of Lot 36 and running thence with the line of said lot N. 55-18 E. 194.9 feet to a stake in line of Lot 23; thence with the line of lots 23 and 24 N. 31-22 W. 49 feet to a stake at corner of Lot 34; thence with the line of said lot S. 61-24 W. 199 feet to a stake on Pecan Drive; thence with the eastern side of said drive S. 35-00 E. 70 feet to the beginning corner."
