Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Four Thousand Four Hundred Fifty and no/100 - Dollars (\$ 4450.00)**, with interest from date at the rate of

four & one-half per centum (4½ %) per annum until paid, said principal and interest being payable at the office of **Canal Insurance Company**

in **Greenville, South Carolina**, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of

Twenty-eight and 16/100 - - - Dollars (\$ 28.16), commencing on the first day of **October**, 19 **54**, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **September**, 19 **74**.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of **Greenville** State of **South Carolina**;

All that lot of land in **Greenville County, State of South Carolina**, on the **Southwestern** side of **Maco Terrace** in the **City of Greenville**, being shown as lot **No. 26A** on a plat of property of **Central Realty Corporation** recorded in **Plat Book "P"** at **Page 51**, and described as follows:

"BEGINNING at a stake on the **Southwestern** side of **Maco Terrace** **440** feet **Southeast** from **Ackley Road** at corner of lot **25 A** and running thence with the **Southwestern** side of said **Maco Terrace** **S. 36-05 E. 55** feet to a stake at corner of lot **26B**; thence with the line of said lot **S. 54-03 W. 145** feet to a stake; thence **N. 36-05 W. 55** feet to a stake at corner of lot **25A**; thence with the line of said lot **N. 54-03 E. 145** feet to the beginning corner."
