, to be paid Five Hundred Dollars on principal  
September 1, 1955; thereafter Three Hundred Dollars quarterly on  
 principal,

, with interest thereon from date hereof

at the rate of 6 per centum per annum, to be computed and paid quarterly from

September 1, 1954 until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

 and recorded in Plat Book Vol. EE at page 81, R.M.C. Office for  
 said County, and having the following courses and distances, to-wit:

 running thence along the center of a proposed 36 foot road, N 17-22 E  
 211.8 feet to a stake; thence N 23-20 E 238 feet to a stake; thence

 N 57-12 E 1064.7 feet to a point in said road (stake off right of

 S 41-45 W 238 feet; S 50-15 W 200 feet; thence S 47-30 W 471 feet to  
 a stake on Eastern edge of said branch; thence S 55-52 E 142.5 feet  
 to an iron pin, cornering with property of (formerly) Donce Gibson;
