I, **Homer Bright** (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate at the northwest corner of **First Avenue and D. Street** on plat of the property of Section 1 of F. W. Poe Manufacturing Company, recorded in Plat Book "Y" at Page 26-27, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwest corner of intersection of **First Avenue and D. Street** and running thence along the northern side of **D. Street N. 48-52 E.** 75 feet to pin at corner of Lot 52; thence with the line of Lot 52 in a northwesterly direction 78.1 feet to a pin in line of Lot 50; thence with the line of Lot 50 S. 49-26 W. 75 feet to pin on **First Avenue**; thence with the northeastern side of **First Avenue** 78.8 feet to the point of beginning.

Said premises being the same conveyed to mortgagor by deed recorded in Deed Book 420 at Page 135.
