# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Marion E. Lauford

(hereinafter referred to as Mortgagor) SENIORS CHILDREN

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgage promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Eight Hundred and Thirty -----  
DOLLARS (\$ 830.00 ), with interest thereon from date at the rate of \_\_\_\_\_ per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, and for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the signing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

beginning on the west side of the old Lutherford Road, about 1/2 mile from the Buncombe Road (State Highway No. 410), and about 1/4 mile from No. 4 of the Butler Greer property, Corner of Brookshire State, and having the following description to-wit:

Beginning at an iron pin on the northwest corner of the Lutherford Road, and running thence N. 21.10 W. 100 feet to an iron pin; thence S. 72.40 W. 80 feet along the Lutherford Road to an iron pin; thence S. 30.20 W. 200 feet to an iron pin; thence N. 57.10 W. 100 feet along said Lutherford Road to the corner.

This is the same property conveyed to the late Mrs. Butler Greer, recorded in Deed Book 37, p. 100, for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging, in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
