"BEGINNING at an iron pin on the northeast side of the White Horse Road at the corner of a lot heretofore conveyed by me to Bayne, which pin is 75 feet southeasterly from the joint front corner of Lots Nos. 1 and 2 as shown on said plat, and running thence along the line of that lot, N. 61-15 E. 200 feet to an iron pin; thence S. 31-07 E. 74.8 feet to a point on the line of a lot heretofore conveyed by me to Childress; thence along the line of that lot, S. 61-15 W. 200 feet to an iron pin on the northeast side of the White Horse Road; thence along the northeast side of the White Horse Road, N. 31-07 W. 74.8 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to me by C. O. Berry by deed dated June, 1937 and recorded in the R. M. C. office for Greenville County in Vol. 207, at page 345."
