"BEGINNING at a point on the west side of Chastain Drive, joint corner of Lots No. 3-A and No. 3-B, which point is N. 14-30 W. 205.3 feet from where said Chastain Drive commences to broaden for intersection with North Franklin Road, and running thence N. 75-30 W. 150.5 feet to rear joint corner of said lots Nos. 3-A and No. 3-B; thence N. 27-57 E. 84.85 feet to joint rear corner of Lots Nos. 3-B and No. 4; thence with line of Lot No. 4, S. 75-30 E. 130.9 feet to point on west side of said Chastain Drive; thence with said Chastain Drive, S. 14-30 W. 82.5 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
