NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Rutherford Street in the City of Greenville and having, according to the plat of the property of Mulberry Corporation by Piedmont Engineering Service, dated January 1955, the following metes and bounds:

BEGINNING at a stake on the Western side of Rutherford Street, said tract being 50.6 feet South of Goodwin Street and running thence S. 70-46 W. 99.4 feet to a point on the Western side of an alley which terminates on the Northern line of the lot herein mortgaged; thence S. 5-09 E. 50.7 feet to a point; thence along line of property of Mrs. Keese this date conveyed to the Mortgagor, N. 70-36 E. 96.1 feet to point on the Western side of Rutherford Street; thence along Rutherford Street N. 0-35 W. 50 feet to the beginning corner, together with any and all right of the Mortgagor to ingress and egress over the aforesaid mentioned alley running from the Northern rear of said lot to Goodwin Street.
