In hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, having the following metes and bounds and courses and distances:-

BEGINNING in the center of the road leading to Pleasant Hill Baptist Church and running thence with said road S 89.00 W. 194.5 feet to a point in the center of said road; thence S. 43.45 W. 173 feet to a bend, thence S. 58.15 W.163 feet to a bend; thence S. 37.00 W. 73 feet to a point in the said road on the bridge; thence down the branch as the line S. 55.45 E. 117 feet to a bend; thence N 72.30 E. 33 feet to a bend; thence S. 1.00 E. 70 feet to a bend; thence S. 42.00 E. 228 feet to a stake in the branch; thence N 20.50 E. 604 feet to a stake in the above said road, the beginning corner, containing three acres.
