NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being known as Lot 7 in a subdivision known as New Furman Heights, and being more particularly described according to plat recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "EE", at page 75, as follows:

BEGINNING at an iron pin on the North side of Ruby Drive at joint front corner of Lots 7 and 8; thence along the line of Lot 8, N. 7-23 E. 177.8 feet to an iron pin; thence along the line of Lots 14 and 15, S. 74-02 E.80.9 feet to an iron pin, joint rear corner of Lots 6 and 7; thence along the line of Lot 6, S. 7-23 W. 165.7 feet to an iron pin on the North side of Ruby Drive; thence with the North side of said Ruby Drive, N. 82-37 W. 80 feet to the point of beginning.
