HOWARD K. McINTYRE and ANNE K. McINTYRE of
Greenville South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

GENERAL MORTGAGE CO., a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fifteen Thousand Nine Hundred Dollars (\$ 15,900.00), with interest from date at the rate of Four & one-half per centum (4½%) per annum until paid, said principal and interest being payable at the office of General Mortgage Co., in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Eighty-eight and 40/100----- Dollars (\$ 88.40), commencing on the first day of June, 19 55, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 19 80.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Meyers Drive (formerly Sunset Drive) in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 10 on Plat of J. R. Jenkinson Property, made by Pickell & Pickell, Engineers, March, 1951, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "Y", page 95, said lot fronting 109.2 feet along the North side of Meyers Drive, running back to a depth of 181.3 feet on the East side, to a depth of 112.2 feet on the West side, and being 170 feet across the rear.

This is the same property conveyed to the Mortgagors by deed of Hazel Lee Jenkinson, et al, dated October 27, 1954, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 511, at page 358.
